ORDINANCE NO. 490

**AN ORDINANCE AMENDING ORDINANCE NO 221, 250, 286
AND ESTABLISHING WARD BOUNDARIES WITHIN
THE CITY OF DETROIT LAKES**

WHEREAS, the City of Detroit Lakes desires to revise its ward boundaries and precincts; and

WHEREAS, Minnesota Statutes 204B.14 and 205.84 provide for the manner in which ward boundaries and precincts may be established.

THEREFORE, The City Council of the City of Detroit Lakes ordains that the following described areas be and they hereby are designated as the election wards within the City of Detroit Lakes:

FIRST WARD – FIRST PRECINCT

All that area within the current corporate limits of Detroit Lakes lying northerly of the west bound centerline of US Highway 10 extending from the easterly corporate limits line to the westerly corporate limits line as both lines cross the said Highway 10 centerline.

SECOND WARD – FIRST PRECINCT

All that area within the current corporate limits of Detroit Lakes lying southerly of the west bound centerline of US Highway 10 extending from the easterly corporate limits line to the centerline of Washington Avenue, easterly of the centerline of Washington Avenue from the centerline of the said Highway 10 to the shoreline of Little Detroit Lake, easterly and southerly across the waters of Little and Big Detroit Lakes to the centerline of Long Bridge and then continuing across the waters to the center of the current corporate limits line between the northerly and southerly shores of Curfman Lake (Dead Shot Bay).

THIRD WARD – FIRST PRECINCT

All that area within the current corporate limits of Detroit Lakes lying southerly of the west bound centerline of US Highway 10 extending from the westerly corporate limits line to the centerline of Washington Avenue, westerly of the centerline of Washington Avenue from the centerline of the said Highway 10 to the shoreline of Little Detroit Lake, easterly and southerly across the waters of Little and Big Detroit Lakes to the centerline of Long Bridge and then continuing across the waters to the center of the current corporate limits line between the northerly and southerly shores of Curfman Lake (Dead Shot Bay).
